**FREIGHT, HANDLING

Returns and Cancellations

Our sales order acknowledgement is final and binding and any change is subject to ability to conform.

NON-WARRANTY RETURNS

Only current standard fixtures with an approved RMA, returned and received by Kirlin within two months of the original ship date, freight prepaid, in their original factory sealed cartons in new condition, are eligible for return. Custom, modified, special, motorized examination lights, discounted or discontinued fixtures or components and all lamps are not returnable for credit. Request for an RMA must be made within 30 days of the invoice date. All returned material must be received by Kirlin within 30 days of the issuance of the RMA. The return is subject to reconditioning charges, testing fees and restocking fee. All returned material must be received by Kirlin within 90 days of original ship date.

WARRANTY-RELATED RETURNS

(See Warranty on "Warranty Information")

If a product is potentially subject to a warranty-related return and/or replacement, an RMA (Return Material Authorization) must be requested and received from Kirlin prior to the return of material.

1. Return material in original cartons, prepaid; mark each carton with RMA#; **use RMA as your packing slip (required).**
2. Material must be received within 30 days of RMA issue date or credit will NOT be issued.
3. Returned material is potentially subject to a restocking fee depending on results of inspection/testing and also on the condition of returned materials.
4. Drivers and lighthouse assemblies must include minimum 5" lead wires, for testing.

CANCELLATIONS: PRIOR TO SHIPMENT

Open Orders for standard fixtures: Subject to cancellation fee for any costs incurred prior to cancellation (including material, labor, processing costs).

Customized Open Orders:* May not be cancelled and will be invoiced in full.

Hold Orders for Standard Fixtures: No cancellation fee.

Customized Hold Orders:* Any engineering, material, labor, and processing costs incurred prior to cancellation, up to 90% of order's value.

* *Customized Orders* are defined as any luminaire with 3 or more standard options; any luminaire with one of the following options: -33, -55, -87, -94, -97, -98, -99, -AT, -CF, -CI, CUF, -DF, -D6, -DAL, -QM, -TA, -WB; or custom luminaire (designated 990 ____).

Luminaire Catalog Number Logic

All our LED luminaire collections (Choice, Latitudes, Symphony, Healthcare, INFRALED PRO, Gazelle, Select, Upgrade/Retrofits, and Shoreview Turtle-Safe) utilize a 3 alpha prefix plus a 5 digit suffix scheme. Each position has specific meaning:
